A person's DNA is inherited equally from each of their parents and is a powerful means of identification. DNA testing is a scientific way of confirming specific biological relationships between different people – parents and children, brothers and sisters, uncles and nephews, etc.

In Australia, DNA testing is sometimes requested to support visa or citizenship applications. You may have received a letter from the Australian Government offering you a DNA test. This brochure outlines the process to undertake DNA testing.

## Why is DNA testing used for immigration?

There are several Australian government departments or tribunal offices which will, at times, ask an applicant or sponsor for confirmation of a biological relationship when assessing applications for visas or citizenship by descent. This confirmation may be in the form of a DNA test to confirm maternity, paternity or other relationships.

DNA testing is a useful option when official documents, such as birth certificates, are unreliable or unavailable. The Department may offer you to undertake DNA testing when it is not satisfied with the available evidence of a claimed relationship.

## How is DNA testing performed?

DNA testing is available for persons either in Australia or overseas. In Australia, the DNA sample collection can be performed at one of our collection centres. When any family members to be tested are outside Australia, a Departmental witness must be present during the DNA sample collection. The Department will only provide a witness if the visa or citizenship application has reached the appropriate stage, where there is an 'offer' for DNA testing.

## What is the process of DNA testing for immigration?

DNA testing for immigration purposes can be an involved process, and our team is here to assist. You will be assigned a case consultant who will oversee your DNA testing case.

- 1 Complete the enclosed application form and send this to us, along with a copy of your letter offering you a DNA test. Application forms can also be found at [www.dnalabs.com.au](http://www.dnalabs.com.au), or call us on 1300 663 244.
- 2 Upon receipt of your application form, payment and copy of your DNA offer letter, instructions and relevant forms are sent to each person being tested in Australia. Cheek swabs are collected from those persons and transported to the laboratory.
- 3 An appointment request is made by our case consultants for the people overseas. The panel physician and a Departmental witness must be present for the DNA sample collection. Following our request, the Department will schedule an appointment for the people overseas. DNALabs will send a blood spot DNA collection kit containing all relevant documents to the overseas panel physician.
- 4 Once the appointment overseas is confirmed, you will be sent a notification with the appointment details. There will be an additional collection fee for the panel physician overseas. (Clarification of this fee can be sought from the panel physician directly prior to attending the appointment.)
- 5 DNA sample collection of all parties is completed and all samples are transported to our laboratory for testing.
- 6 Within 5-10 working days of receiving all samples in our laboratory, the results of the DNA testing are sent to the Departmental office that offered your DNA test. They will also be sent to the nominated address provided on your application form.
